**Amendment to Budget Bill Item 8500-001-0152, Support, Board of Chiropractic Examiners**

**Amendment to Budget Bill Item 8530-001-0290, Support, Board of Pilot Commissioners**

**Amendment to Budget Bill Items 8570-001-0001 and 8570-001-0601, Support, California  
Department of Food and Agriculture**

It is requested that Item 8570-001-0601, Agriculture Building Fund, be increased by \$2.0 million and that Item 8570-001-0001 be amended to reflect this change. The funds are necessary to replace and upgrade the Heating, Ventilation, and Air Conditioning (HVAC) system at the Center for Analytical Chemistry (CAC) at the Meadowview property in Sacramento due to conditions that threaten property damage and the health and safety of laboratory staff. Beginning in fiscal year 2009-10, the CAC's Analytical Laboratory Account, Department of Food and Agriculture Fund, will repay, with interest, the Agriculture Building Fund on a payment schedule not to exceed 10 years.

**Amendment to Budget Bill Item 8570-301-0001, and Addition of Budget Bill  
Items 8570-301-0601 and 8570-301-0660, Capital Outlay, Department of Food and  
Agriculture**

It is requested that Item 8570-301-0001 be decreased by \$2,587,000 for the California Animal Health and Food Safety Laboratory: Tulare/Fresno: Laboratory Consolidation and Replacement project to reflect a fund shift from General Fund to the Public Buildings Construction Fund for the working drawings phase of this project. Item 8570-301-0660 has been added below to reflect the increase in lease-revenue bond authority consistent with this fund shift.

It is requested that Item 8570-301-0601 be added to reflect an increase of \$2.3 million from the Agriculture Building Fund for the California Animal Health and Food Safety Laboratory: San Bernardino—Acquisition project. This project will authorize the acquisition of 3 acres of leased property in San Bernardino to secure the existing site for the California Department of Food and Agriculture (CDFA) California Animal Health and Food Safety (CAHFS) lab. Although CDFA owns the lab, the land beneath the lab is leased from the National Orange Show. Purchase of the land will protect the state's investment in the laboratory facilities and will eliminate annual lease payments. It is further requested that provisional language be added to this item as follows:

1. Purchase of the land occupied by the San Bernardino Veterinary Laboratory will be paid out of the Department of Food and Agriculture's Agriculture Building Fund. These costs, including staff costs and interest are to be repaid from the General Fund, subject to an appropriation for this purpose, to the Agriculture Building Fund, beginning in the 2009-10 fiscal year with payment in full no later than June 30, 2019.

It is requested that Item 8570-301-0660 be added to reflect an increase of \$44,937,000 from the Public Building Construction Fund for the California Animal Health and Food Safety Laboratory: Tulare/Fresno: Laboratory Consolidation and Replacement project. This increase reflects a fund shift from the General Fund to the Public Buildings Construction Fund for working drawings (\$2,587,000), as well as the additional construction funds (\$40,515,000), and equipment (\$1,835,000) costs for the replacement CAHFS facility in Tulare, which is required for lease-revenue bond financing. It is further requested that provisional language be added to this item as follows:

1. The State Public Works Board (SPWB) may issue lease-revenue bonds, notes, or bond anticipation notes pursuant to Chapter 5 (commencing with Section 15830) of Part 10b of Division 3 of Title 2 of the Government Code to finance the design, construction, and equipping of the project authorized by this item.
2. The SPWB and the Department of Food and Agriculture (CDFA) may obtain interim financing for the project costs authorized in this item from any appropriate source, including but not limited to, the Pooled Money Investment Account pursuant to Sections 16312 and 16313 of the Government Code.
3. The SPWB may authorize the augmentation of the costs of design, construction, and equipping of the project scheduled in this item pursuant to the Board's authority under Section 13332.11 of the Government Code. In addition, the SPWB may authorize any additional amount necessary to establish a reasonable construction reserve and to pay the cost of financing, including the payment of interest during construction of the project, the costs of financing a debt service fund, and the cost of issuance of permanent financing for the project. This additional amount may include interest payable on any interim financing obtained.
4. The CDFA is authorized and directed to execute and deliver any and all leases, contracts, agreements, or other documents necessary or advisable to consummate the financing of the project authorized in this item.
5. The SPWB shall not be deemed a lead or responsible agency for purposes of the California Environmental Quality Act (CEQA) (Division 13 [commencing with Section 21000] of the Public Resources Code) for any activities under the State Building Construction Act of 1955 (Part 10b [commencing with Section 15800] of Division 3 of Title 2 of the Government Code). This provision does not exempt the CDFA from the requirements of CEQA. This provision is intended to be declarative of existing law.
6. Notwithstanding any other provision of law, the funds appropriated in this item shall be available for encumbrance or expenditure during the 2008-09 fiscal year, except appropriations for working drawings which shall be available for expenditure until June 30, 2010, and appropriations for construction and equipment, which shall be available for encumbrance or expenditure until June 30, 2013. In addition, the balance of funds appropriated for construction that have not been allocated, through fund transfer or approval to bid, by the Department of Finance on or before June 30, 2011, shall revert as of that date to the fund from which the appropriation was made.

**Amendment to Budget Bill Items 8940-001-0001, 8940-001-0890, and Reimbursements, Support, California Military Department**

It is requested that Item 8940-001-0890 be increased by \$280,000 and Reimbursements be increased by \$2,920,000 to reflect the following:

- **Homeland Security Grant**—An increase of \$800,000 Reimbursements and 6.0 positions (5.7 personnel years) are requested to reflect increased reimbursement authority for the Homeland Security Grant received from the Office of Homeland Security (OHS). This funding will be used to provide planning, exercises, coordination, and command and control for various emergencies.
- **Critical Infrastructure Protection Teams**—An increase of \$2,120,000 Reimbursements and 14.0 positions (13.3 personnel years) are requested to reflect increased reimbursement authority from the OHS to establish and support two Critical Infrastructure Protection Teams (Teams). These Teams will conduct vulnerability assessments and develop recommendations to reduce the risk of damage to the state's critical infrastructure in the event of an emergency or disaster.
- **Sunburst Youth Academy**—An increase of \$280,000 federal funds and 3.0 positions (2.8 personnel years) are requested to reflect increased federal funds to the Military Department's Sunburst Youth Academy (Academy). These resources will be used to support the Academy and its goal of instilling values, skills, education, and self-discipline in at-risk youth to prepare them to become responsible adults in their community.

**Amendment to Budget Bill Item 8955-001-0001, Addition of Budget Bill Items 8955-001-3085 and 8955-101-3085, Support and Local Assistance, California Department of Veterans Affairs**

It is requested that Item 8955-001-0001 be increased by \$380,000 and 7.1 personnel years to provide staffing to improve monitoring and assistance provided to residents during mealtimes in the Veterans Home (VHC) at Yountville. This staffing is necessary to lessen health risks and enhance the safety of the aging and disabled members in the VHC at Yountville.

It is requested that Item 8955-001-3085 be added in the amount of \$226,000 and that Item 8955-001-0001 be amended to reflect this change, and that Item 8955-101-3085 be added in the amount of \$270,000. These funds from the Mental Health Services Account will provide 1.9 positions for the development of a statewide network for veteran mental health referrals. These funds will also provide a coordinated effort through the network, at the County level, including the County Veterans Service Offices, to ensure that veterans and their families seeking mental health assistance are referred for service through any available access point.

3. Notwithstanding any other provision of law, the minimum grant provided to law enforcement jurisdictions pursuant to subdivision (c) of Government Code Section 30061 shall be \$90,000.

This language is consistent with the intent of the budget-balancing reduction proposed in the Governor's Budget, which proposed that all grants be reduced by 10 percent.
