**Amendment to Budget Bill Item 1111-002-3122 and Elimination of Item 1110-011-0208, Support, Department of Consumer Affairs—Bureaus and Boards**

The requested adjustments are reflected below.

**Technical Adjustment to the Enhanced Fleet Modernization Program (Issue 201)**—A net zero change to accurately reflect \$35.6 million limited term funding expiring in 2011-12 and the restoration of \$35.6 million on a two-year limited term basis in 2012-13 and 2013-14. The adjustments will correct a technical error in the 2012-13 Governor's Budget which identified this funding as ongoing.

**Removal of Item 1110-011-0208 (Issue 001)**—This Item provides authority to transfer the remaining balance from the Hearing Aid Dispensers Account of the Speech-Language Pathology and Audiology Fund to the Speech-Language Pathology and Audiology and Hearing Aid Dispensers Fund on June 30, 2013. This transfer authority is no longer necessary because the transfer has already occurred as authorized by Government Code Sections 16304.8-16304.9.

**Voluntary Contribution Check-Off Funds (Issue 025)**—It is requested that Items 1730-001-8053—ALS/Lou Gehrig's Disease Research Fund, 1730-001-8055—Municipal Shelter Spay-Neuter Fund, and 1730-001-8069—Child Victims of Human Trafficking Fund each be increased by \$6,000, and that Item 1730-001-0001 be amended to reflect these changes. **Addition of Budget Bill Item 1760-490, Capital Outlay, Department of General Services**

It is requested that Item 1760-490 be added to extend the liquidation period to June 30, 2013, for the following items:

Item 1760-301-0660, Budget Act of 2002, as reappropriated by the Budget Acts of 2003, 2005, 2007, 2010, and 2011, and Item 1760-301-0660, Budget Act of 2005, as reappropriated by Item 1760-491, Budget Act of 2010 and 2011, for the construction phase of the Office Building 8 and 9 Renovation project. This project is substantially complete, however, some minor work related to accessibility and security of the building remains outstanding, and it is uncertain if this work will be completed by the end of the current fiscal year.

Item 1760-301-0660, Budget Act of 2003, as reappropriated by the Budget Acts of 2004, 2005, 2007, 2010, and 2011, for the construction phase of the Central Plant Renovation. This project is substantially complete, however, there is a minor amount of closeout work, such as commissioning and system programming activities, that needs to be completed. Because this work may not be completed by the end of this fiscal year, the extension would ensure the Department of General Services (DGS) can pay the contractor when the work is complete.

Item 1760-301-0660, Budget Act 2003, as reappropriated by the Budget Acts of 2004, 2005, 2007, and 2011, for the construction phase of the Marysville Office Replacement project. This project is substantially complete; however, DGS cannot close out the project until Leadership in Energy and Efficiency Design certification has been obtained, which may not occur until after June 2012. This extension is needed to ensure timely payment of all contract liabilities.
