<b><u>Purpose</u></b> The Professions and Vocations Fund consists of several subfunds, listed in Section 205, that were established for the purpose of regulating business and professions. Each account or subfund is available for expenditure only for the purposes provided by the specific laws regulating the particular business or profession.
