| <b><u>Comments/Historical Information</u></b><br>Chapter 1247, Statutes of 1986 (SB 2119) created this fund under Health and Safety Code section 4057.7. Chapter 415, Statutes of 1995 repealed Health and Code section 4057.7 and moved it to Health and Safety Code section 116860.<br>Chapter 241, Statutes of 2006 changed the administering agency from org 4260 to 4265 due to the split of Department of Health Services into two separate entities: Department of Health Care Services/Org 4260 and Department of Public Health/Org 4265.<br>Chapter 35, Statutes of 2014 changed the administering agency from Department of Public Health/Org 4265 to State Water Resources Control Board/Org 3940. |  |                                      |
