**Amendment to Budget Bill Item 1110-001-0326, Support, Department of Consumer Affairs**

**Athletic Commission Budget Bill Language (Issue 305)**—It is requested that Budget Bill language be added to Item 1110-001-0326 to provide the Department of Finance with the authority to augment this item by up to \$200,000, contingent upon sufficient funding in the Athletic Commission Fund. This language will ensure funding can be made available for an adequate number of Athletic Inspectors at regulated sporting events to ensure the health and safety of the participants and to provide required Athletic Inspector training (Attachment I).

**Attachment I**

**Add Budget Bill Language**

**Add the following provision to Item 1110-001-0326**

X. Provided that sufficient funds are available and upon request by the Department of Consumer Affairs, the Department of Finance may augment this item by up to \$200,000 not sooner than 30 days after notification in writing is provided to the chairpersons of the fiscal committees in each house of the Legislature and the Chairperson of the Joint Legislative Budget Committee. This augmentation shall only be provided for additional funding needed for Athletic Inspectors at sporting events or for Athletic Inspector training.
