**Amendment to Budget Bill Items 0690-001-0001 and 0690-001-0029, Support,
and Items 0690-101-0029, 0690-102-0001, 0690-102-0890, and 0690-112-0001,
Local Assistance, Office of Emergency Services**

It is requested that Item 0690-001-0001 be increased by \$3,745,000, Item 0690-001-0029 be increased by \$35,000, Item 0690-101-0029 be increased by \$85,000, Item 0690-102-0001 be increased by \$1.0 million, Item 0690-102-0890 be decreased by \$9,135,000, and Item 0690-112-0001 be increased by \$19,963,000, to reflect the following adjustments:

- **Consumer Price Index Adjustment to the Nuclear Planning Assessment Special Account**—An increase from the Nuclear Planning Assessment Special Fund of \$120,000 (\$35,000 State Operations, \$85,000 Local Assistance) is requested pursuant to Government Code Section 8610.5. This is an annual adjustment based on economic changes reflected in the California Consumer Price Index.
- **Disaster Response and Recovery Funding**—An increase from the General Fund of \$23,708,000 (\$3,745,000 State Operations, \$19,963,000 Local Assistance) is requested to fund the estimated costs of response to, and recovery from disasters, including the recent federally-declared disaster known as the 2006 Winter Storms. This amount represents the state's share of the costs of disaster response and recovery, as defined in the California Disaster Assistance Act.
- **Federal Residential Substance Abuse Treatment Funding**—A decrease of \$9,135,000 in Federal Trust Fund authority is requested, to eliminate the Residential Substance Abuse Treatment funding that will no longer be provided by the federal government.
- **Assistance for Victims of Crimes Committed by Parolees**—An increase from the General Fund of \$1.0 million is requested to provide additional funding for local Victim-Witness Resource Centers. This funding will be used to extend support services to victim-witnesses who participate in the state's parole revocation hearing process.

Amendment to Various Budget Bill Items, Support and Local Assistance, and Addition of Item 0820-490, Reappropriation, Department of Justice

It is requested that Item 0820-001-0001 be increased by \$3.1 million to handle class action cases received from the California Department of Corrections and Rehabilitation. We also request that language (Attachment 1) be added to restrict the use of funds as budgeted for the Correctional Law Section.

It is further requested that Item 0820-001-0001 be increased by \$81,000, with a corresponding decrease of \$81,000 in Item 0820-001-0256. This fund shift is necessary to continue funding for the Megan's Law Program at its current level, and is a result of declining revenue to the Sexual Predator Public Information Account.

It is requested that the following items be increased to fund the creation of a new Supervising Deputy Attorney General classification within the Department of Justice (DOJ) to improve their supervisory ratio for attorneys:

- 0820-001-0012 \$4,000
- 0820-001-0014 \$6,000
- 0820-001-0158 \$4,000
- 0820-001-0367 \$1,000
- 0820-001-0557 \$7,000
- 0820-001-0890 \$107,000
- 0820-001-3053 \$18,000
- 0820-001-3061 \$27,000
- 0820-001-3088 \$8,000
- 0820-001-9731 \$364,000
- Reimbursements \$9,000

It is requested that Item 0820-001-0890 be increased by \$487,000 to reflect a new federal grant award from the National Institute on Justice, for Information-Led Policing Research, Technology Development, Testing, and Evaluation.

We note that approval of this request requires a Feasibility Study Report (FSR). Due to timing issues with the federal grant process, an FSR has not yet been submitted. In order to maximize the use of available federal funding, we request language (Attachment 2) that restricts the DOJ from spending these funds until an FSR has been approved by the Department of Finance and reviewed by the Legislature.

It is requested that Item 0820-001-3061 be increased by \$4,194,000 to continue investigation and litigation activities arising from California's electricity and natural gas emergency. To ensure that the DOJ does not spend more than it recovers, we request language (Attachment 3) that aligns expenditures with actual recoveries.

It is requested that Reimbursements be increased by \$517,000 to accept a new grant award from the Office of Traffic Safety for a Responsible Adults-Safe Teens Project, which will allow the DOJ to develop and implement a public awareness campaign that encourages parents and adults to comply with the laws against providing alcohol to minors.

It is requested that Item 0820-490 be added to reappropriate up to \$3,590,000 from Item 0820-001-0890, Budget Act of 2005, Program 50, Division of Law Enforcement, for the Single-Point Information, Collection, and Evaluation System (\$1.0 million), and the Threat, Analysis, Reporting, and Geographic Evaluation Tool (\$2,590,000) projects (Attachment 4). This reappropriation is necessary due to delays in the procurement process, which will prevent the DOJ from encumbering these funds in the current year.

It is also requested that Items 0820-001-0001 and 0820-101-0001 be amended to reflect technical adjustments, as follows:

- Decrease Item 0820-001-0001 by \$283,000, and increase Item 0820-101-0001 by \$283,000, and delete Provision 4 from Item 0820-001-0001 which requires the DOJ to transfer \$283,000 to Item 0820-101-0001 to support the Spousal Abuser Prosecution Program.
- Transfer the Facilities Protection Unit (\$954,000) from the Administrative Services Division to the Division of Law Enforcement, the Fiscal Systems Unit (\$408,000) from the Administrative Services Division, to the Division of California Justice Information Services, and the Office of Professional Development and Case Management (\$507,000) from the Executive Programs Division to the California Justice Information Services.

- X. Of the funds appropriated in this item, \$20,528,000 is available solely for the Correctional Law Section which handles only workload related to California Department of Corrections and Rehabilitation cases, and of that amount \$3,794,000 is restricted to class action workload.

Provisions:

1. Of the funds appropriated in this item, \$487,000 is for the Information-Led Policing Research, Technology Development, Testing, and Evaluation grant. These funds may not be encumbered or expended until a Feasibility Study Report has been approved by the Department of Finance. The Department of Finance's approval shall be effective not sooner than 30 days after notification in writing to the Chairperson of the Joint Legislative Budget Committee of the approval.

Unclaimed Property System Replacement

It is requested that Item 0840-001-0001 be increased by \$1,573,000 in 2006-07 and 5.0 one-year limited-term positions be provided to replace the existing Unclaimed Property System and supporting applications and spreadsheets with a commercial-off-the-shelf system. The implementation period is 18 months. The project is expected to generate resources savings of \$261,000 and 1.6 PYs in 2007-08, which will increase to \$1,174,000 and 15.4 PYs in 2010-11 and thereafter. This project will require net funding of \$536,000 General Fund and 2.5 one-year limited-term positions in 2007-08, which reflects the anticipated savings of \$261,000 in 2007-08.

Unclaimed Property Program Auditors

It is requested that Item 0840-001-0001 be increased by \$1,441,000 and 15.0 two-year limited-term positions be provided to increase audits of unclaimed property holders in California to ensure they are complying with Unclaimed Property law. The State Controller's Office (SCO) estimates that the increase audit staffing will result in \$7.5 million in additional unclaimed property receipts in 2006-07 and \$15.0 million in 2007-08 and annually thereafter.

Unclaimed Property Program Workload

It is requested that Item 0840-001-0001 be increased by \$620,000 and 7.5 two-year limited-term positions be provided to eliminate the backlog of notices related to security claims which is required to be sent to unclaimed property owners under Section 1531(d) of the Code of Civil Procedures. The SCO estimates that working down this backlog will increase unclaimed property claims by \$8.2 million in 2006-07 and 2007-08.

Generally Accepted Accounting Principles Compliance Workload

It is requested that Item 0840-011-0494 be increased by \$15,000, 0840-011-0797 be increased by \$58,000, and 0840-011-0988 be increased by \$14,000, and that Item 0840-001-0001 be amended to reflect this change. It is also requested that one permanent position be provided to fund increased workload associated with the preparation of various annual financial reports in compliance with Generally Accepted Accounting Principles.

It is requested that Item 0890-001-0228 be increased by \$2,210,000 to provide ongoing maintenance and operation costs for the Uniform Commercial Code phase of the Business Programs Automation project.

Amendment to Budget Bill Item 0977-001-6046, Support, California Health Facilities Financing Authority

It is requested that Item 0977-001-6046 be increased by \$76,000 to fund one permanent position (Junior Staff Analyst) and related operating expenses and equipment to address workload for administration of local assistance grants for children's hospitals, pursuant to Proposition 61.

Proposition 61, passed by the voters on November 2, 2004, authorizes the issuance of \$750 million General Obligation Bonds to fund the Children's Hospital Program. The California Health Facilities Financing (Authority) was designated as the administering agency for the Children's Hospital Program. Proposition 61 authorizes the use of up to 1 percent of the bond proceeds for administration costs of the Authority. Based on workload estimates from similar programs, the Authority originally requested two permanent positions to administer this program. Now that the program has begun operations, the Authority requires an additional position due to various factors, including the unanticipated stringent documentation standards of the program, the ability of hospitals to apply multiple times, and the mandated 60-day review period for each application.
