**Amendment to Various Budget Bill Items, Support, Department of Consumer Affairs**

It is requested that the Items pertaining to the Department of Consumer Affairs (DCA), Boards and Bureaus below, be amended to reflect the following changes:

**Dental Board of California**—Increase Item 1110-001-0741 by \$79,000 to provide ongoing resources for changes to the Board's, Licensure by Credential Program, as mandated by Chapter 4, Statutes of 2006 (SB 299).

**Bureau of Automotive Repair**—Increase Item 1111-002-0582 by \$3,675,000 for the purpose of increasing participation in the Vehicle Retirement Program. Under this proposal, certain eligibility requirements would be relaxed in order to expand the number of voluntary vehicle retirements.

**iLicensing Project**—It is requested that various DCA Budget Bill Items be increased to provide for the implementation of the iLicensing system. See Attachment A for a list of the Items impacted by this requested change.

It is also requested that Control Section 4.55 be deleted in conjunction with this action, and that provisional language (Attachment B) be added to Item 1111-002-0702, to require the DCA to report on specified aspects of the iLicensing Project.

**Language to require the Department to report on the ongoing workload associated with iLicensing**

Item 1111-002-0702

Provisions:

XX. The Department of Consumer Affairs shall report to the Department of Finance and the Joint Legislative Budget Committee on the status of the iLicensing project and shall provide a workload analysis for the positions established to support this project by September 1, 2009. The Department of Finance may eliminate any position established in the 2006 Budget, which supports the iLicensing project, if the workload cannot be justified by the report.

**Phase III Occupancy Costs—Butterfield Office Complex (Issue 017)**—It is requested that Item 1730-001-0001 be increased by \$21,611,000, Item 1730-001-0044 be increased by \$101,000, Item 1730-001-0064 be increased by \$188,000, Item 1730-001-0242 be increased by \$282,000, and Reimbursements be increased by \$1,854,000 to reflect facility related costs for the Franchise Tax Board's (FTB) Butterfield Office Complex. It also is requested that Item 8640-001-0001 be increased by \$82,000 to reflect monies received pursuant to the Political Reform Act.

This request will pay for increased rental and maintenance costs for FTB's new Phase III buildings which they occupied in 2005.

**Tax Gap and Discovery Audits—Full Year Annualization (Issue 018)**—It is requested that Item 1730-001-0001 be increased by \$659,000 to reflect full-year, ongoing funding for the tax gap and discovery audit program staff provided in the Budget Act of 2005.

**Amendment and Addition of Various Budget Bill Items, Support and Local Assistance, Department of General Services, and Addition of Control Section 4.75, Statewide Surcharge**

It is requested that Item 1760-001-0002 be increased by \$607,000, Item 1760-001-0367 be added to appropriate \$50,000, Item 1760-001-0602 be reduced by \$1,341,000, and Item 1760-001-0666 be amended to reflect these changes. It is also requested that Item 1760-001-0666 be increased by \$5,575,000, and that Item 1760-101-0022 be reduced by \$19,303,000.

Finally, it is requested that Control Section 4.75 be added to the Budget Bill. Specifically, these changes are requested as follows:

**Nelles Consultant Costs**—Increase Item 1760-001-0002 by \$607,000 to provide consulting funds necessary to perform specified activities related to the sale of the Fred C. Nelles facility in Whittier. It is also requested that Provision 2 of this item be updated to reflect this change (Attachment I).

**Inspection Verification Services**—Add Item 1760-001-0367 to appropriate \$50,000 for construction and inspection verification services at tribal gaming facilities (Attachment II). In conjunction with this request, Item 1760-001-0602 would be reduced by \$40,000 to reflect the redirection of 0.3 personnel years from Department of General Services Real Estate Services Division to this activity.

**San Quentin Condemned Inmate Complex**—Decrease Item 1760-001-0602 by \$1,301,000 and 9.4 personnel years to reflect the revised schedule for this project resulting from delays in construction.

**Statewide Child Support Printing**—Increase Item 1760-001-0666 by \$4,372,000 for equipment and materials necessary for the Office of State Publishing to implement a centralized print and mail system for the Department of Child Support Services.

**Enhanced Wireless 911 Technical Adjustment**—Decrease Item 1760-101-0022 by \$19,303,000, due to a technical error in the Governor's Budget. In addition to this reduction, it is requested that this item be revised to schedule Enhanced Wireless 911 expenditures separately from ongoing base program expenditures (Attachment III).

**Various Departmental Services**—Increase Item 1760-001-0666 by \$1,203,000 and 11.6 personnel years for the following:

- \$101,000 for deferred maintenance in the Public Utilities Commission building
- \$852,000 for custodial services in the CalTrans Traffic Management Center
- \$250,000 for operations and maintenance startup costs in Office Building 10, which will be occupied by the Department of Rehabilitation beginning in 2007-08.

Funds to reimburse the Department of General Services for these services are contained within the individual budgets of the client departments.

**Statewide Surcharge**—Add Control Section 4.75 to allow the Director of Finance to adjust various items of appropriation as needed for departments to pay centralized costs included in the Statewide Surcharge (Attachment IV).

**Amendment to Budget Bill Item 1760-301-0768, Capital Outlay, and Addition of Items 1760-491, Extension of Liquidation, and 1760-495, Reversion, Department of General Services**

It is requested that Item 1760-301-0768 be increased by \$2,580,000 to provide construction costs for the Structural Retrofit of Hospital Building, Wing B at Deuel Vocation Institute. This is a net increase of \$827,000 for construction costs due to a delay in the installation of a heating, ventilating, and air conditioning project, which needed to be completed prior to the commencement of the structural retrofit. The original appropriation of \$1,753,000 is proposed for reversion (See Item 1760-495).

It is requested that Item 1760-491 be added to extend the liquidation period for the working drawings of the San Quentin Building 22. This extension is needed to provide adequate time to bid the project. (See Attachment 1)

It is requested that Item 1760-495 be added to revert funding for the Structural Retrofit of Hospital Building, Wing B at Deuel Vocation Institute. A new appropriation of \$2,580,000 will be added to complete the project (See Item 1760-301-0768). This item would revert the construction costs of \$1,753,000 that was reappropriated by Item 1760-490, Budget Act of 2005. (See Attachment 2)

**Amendment to Budget Bill Item 1900-001-0950 and Addition of Budget Bill Item 1900-001-0942, Support, California Public Employees' Retirement System**

It is requested that Item 1900-001-0950 be increased by \$2,935,000 to provide one-time funding to enable California Public Employees' Retirement System (CalPERS) to perform a requirements analysis and cost study to determine the feasibility of accepting contracting agencies' pre-funding contributions for Other Post-Employment Benefits (OPEB) liabilities. Effective at the end of the 2007-08 fiscal year, public agencies must begin disclosing the amount of their unfunded liability for retiree benefits other than pensions. CalPERS intends to provide contracting agencies with a single point of service for the actuarial studies required to determine the unfunded liability of their retiree benefits, usually health care.

It is requested that Item 1900-001-0942 be added in the amount of \$489,000 and 5.5 positions to provide resources for the CalPERS Health Benefits Branch to implement the processing of Medicare Part D eligibility files and subsidy requests. The federal Medicare Part D provides subsidies to employers who provide prescription drug coverage for their retirees in Medicare. It is estimated that the state's subsidy for retiree health care will be approximately \$38 million for fiscal year 2006-07, which will be deposited into a Special Deposit Fund. These resources will enable CalPERS to request this subsidy as the state's agent.

The effect of my requested action is reflected on the attachment.
