**Amendment to Budget Bill Item 7501-001-0001 and Reimbursements, Support,  
Department of Human Resources**

It is requested that Item 7501-001-0001 be increased by \$424,000 and reimbursements be increased by \$424,000 and also an increase of 5 positions in fiscal year 2014-15 be added to the California Department of Human Resources (CalHR) to provide additional resources for labor relations on behalf of the California In-Home Supportive Services Authority. In order to align bargaining obligations to when counties are expected to fully implement the Coordinated Care Initiative, 2 positions will have an effective date of July 1, 2014, 5 positions will become effective January 1, 2015, and 2 positions will become effective April 1, 2015. This will result in 9 ongoing positions starting in 2015-16.

Pursuant to Chapter 45, Statutes of 2012 (SB 1036), CalHR will represent the California In-Home Supportive Services Authority on all aspects of labor relations for the In-Home Supportive Services Employer-Employee Relations Act. These resources will be used to negotiate with and continue implementation of labor relations, contract administration, collective bargaining, mediation, and other legal proceedings. CalHR will utilize these resources to begin bargaining for the counties as the state becomes responsible to negotiate these contracts.

**Addition of Trailer Bill Language to amend Government Code, Department of Human Resources**

**Limited-Term Positions**—It is requested that trailer bill language be added to amend Government Code section 19080.3 to permit limited-term appointments for up to five years consistent with limited-term positions approved through the budget process. This change is necessary to allow departments to maintain work teams on critical limited-term projects, like information technology projects. This bill also makes a technical change to align limited-term appointments to be authorized at two years as is current practice.

Section 19080.3 of the Government Code is amended to read:

Limited-term appointments shall only be made under the following conditions:

(a) ~~Limited-term appointments shall may be made only for temporary staffing needs and shall not individually or consecutively exceed one two years, provided that the board may authorize limited term appointments of up to a total of two years' duration when if a permanent appointment would be likely to cause a layoff, demotion, or mandatory transfer requiring a change of residence upon the conclusion of the temporary staffing need. Limited term appointments may be extended within the time limits prescribed by this section without making an additional appointment.~~

(b) Limited-term appointments may be made for limited-term positions, only if the limited-term position has been approved through the budget process. The department, pursuant to board rule, may authorize these types of limited-term appointments for a period not to exceed the length of time of the project and, in no event, to exceed five years.

**Amendment to and Addition of Various Budget Bill Items, Support, Department of General Services**

**Office of Public School Construction Audit Funding Shift (Issue 200)**—It is requested that Item 7760-001-6057 be increased by \$560,000 and that Item 7760-001-0666 be amended to reflect this change. This request will accelerate, by one fiscal year, bond authority used to fund the oversight of audits for the Kindergarten-University Public Education Facilities Bond Act of 2006 (Proposition 1D) by the Department of Finance, Office of State Audits and Evaluations. This request is cost-neutral over the life of the Proposition 1D bond and will more appropriately align audit resources with program needs. (See related issue 100, Item 6350-602-6057.)

**Water Conservation and Drought Response (Issue 201)**—It is requested that Item 7760-001-0666 be increased by \$5.4 million to implement water efficiency and conservation measures in state-owned facilities. The additional funding will provide the resources necessary to replace existing plumbing fixtures and irrigation systems at the State Capitol and other state-owned facilities. This increase in expenditure authority will result in a one-time \$0.05 per square foot increase in the Individual Building Rental Rate and the Building Rental Account Rate, and an increase to the Statewide Surcharge of \$275,000 to recover the costs.

**Transfer Position to the Emergency Repair Program (Issue 203)**—It is requested that Item 7760-001-3082 be added in the amount of \$83,000, Item 7760-001-0961 be deleted, and that Item 7760-001-0666 be amended to reflect this change. This action is necessary to ensure that the Office of Public School Construction (OPSC) within the Department of General Services has the resources needed to administer the Emergency Repair Program (\$188.5 million is provided for this program in the budget proposal). (See related issues 761 and 772 in Items 6350-605-3082, 6350-698-3082, 6350-620-0961, 6350-621-0961, and 6350-698-0961.)

**Transfer Unused Site Program Funds to the School Facility Program (Issue 204)**—It is requested that Item 7760-001-0956 be added in the amount of \$5,388,000, Item 7760-001-6057 be reduced by \$5,388,000, and that Item 7760-001-0666 be amended to reflect this change. This action is necessary to utilize funds available from the Unused Site Program for support of the School Facility Program, administered by the OPSC. The unused site fees have previously been used to support the Deferred Maintenance Program. However, this categorical program was folded into the Local Control Funding Formula. This adjustment will offset a like amount of state bond funds used for administration of the School Facility Program, allowing more bond

funds to be used for the physical construction of school facilities. The Unused Site Program generates fee revenue of approximately \$2.8 million annually and trailer bill language (Attachment I) is required to redirect these funds ongoing to the support of the School Facility Program. (See related issue 103, Item 6350-601-0956, issue 102, Item 6350-602-0956, issue 761, Item 6350-620-0961, and issue 101, Item 6350-602-6057.)

Proposed Trailer Bill

**Transfer Unused Site Program Funds to School Facility Program (New for May Revision)**

Section 17224 of the Education Code is amended to read:

17224. (a) Any funds in the State School Site Utilization Fund, including interest, that are not subject to return to a school district pursuant to Section 17223 shall ~~revert to the Deferred Maintenance Fund.~~ be allocated for the purpose of administering the Leroy F. Greene School Facilities Act of 1998.

(b) Any funds in the Deferred Maintenance Fund as of July 1, 2014 shall be transferred to the State School Utilization Fund.

**Amendment to Various Budget Bill Items, Support, California Public Employees' Retirement System**

It is requested that Item 7900-003-0830 be decreased by \$19,393,000, Item 7900-015-0815 be decreased by \$286,000, Item 7900-015-0820 be decreased by \$60,000, Item 7900-015-0822 be increased by \$522,000, Item 7900-015-0830 be increased by \$11,582,000 and 42 positions, Item 7900-015-0833 be decreased by \$235,000, Item 7900-015-0884 be decreased by \$12,000, and reimbursements to the main item be decreased by \$2,713,000 to reflect the request by the California Public Employees' Retirement System (CalPERS) to incorporate their approved budget into the Budget Act.

The Budget Bill items mentioned above are display items for informational purposes to reflect a corresponding change in CalPERS' continuous appropriation authority. These changes reflect the fiscal year 2014-15 budget approved during the April 16, 2014 CalPERS board meeting.

**Amendment to Budget Bill Item 7920-011-0001, Support, California State Teachers' Retirement System**

It is requested that Item 7920-011-0001 be increased by \$76,219,000 to support the California State Teachers' Retirement System (CalSTRS). This increase is comprised of the following adjustments:

- An increase of \$73,232,000 due to the Administration's proposed funding plan to put CalSTRS on a sustainable path and eliminate the unfunded liability. The proposed change in the pre-1990 benefit level funding policy will accelerate state contributions to eliminate the CalSTRS' unfunded liability in 30 years. Under the funding plan, the state's contribution will increase from 3 percent to 6.3 percent over the next three years. School district and teacher contributions will also increase under the plan. Trailer Bill language will follow.
- An increase of \$1,101,000 due to the increase in the creditable compensation reported by CalSTRS.
- An increase of \$521,000 for the pre-1990 benefit level payment.
- An increase of \$1,365,000 for the Supplemental Benefit Maintenance Account contribution.

The three latter bullets are existing statutory funding requirements.
