**Amendment to and Addition of Various Budget Bill Items, Support and Local Assistance, Judicial Branch**

**Support of Trial Court Operations**—The May Revision proposes \$160 million for operations of the trial courts to replace the \$100 million proposed in the Governor's Budget and a two-year funding approach to stabilize trial court funding. This approach will allow the Judicial Council sufficient time to evaluate and pursue workload process changes and efficiencies that will modernize court operations and improve access to justice measures.

It is requested that Items 0250-101-0932 and 0250-111-0001 be amended to reflect the following:

- A decrease of \$100 million proposed in the Governor's Budget.
- An increase of \$86.3 million to reflect an augmentation equal to 5-percent of the amount appropriated in Program 45.10-Support for Operation of Trial Courts. The Administration intends to support an additional 5-percent increase in the 2015-16 Governor's Budget.
- An increase of \$42.8 million to reflect increased costs for health benefit and retirement adjustments for trial court employees. Assuming progress towards meeting the standards set by the Public Employees' Pension Reform Act (PEPRA) for existing employees, the Administration is committed to funding future increases related to existing health benefits and retirement costs for trial court employees and retirees one year in arrears.

**Trial Court Trust Fund Revenue**—It is requested that Item 0250-101-0932 be decreased by \$30.9 million to reflect the estimated revenue loss anticipated in the Trial Court Trust Fund in fiscal year 2014-15. It is requested that Item 0250-113-0001 be added in the amount of \$30.9 million and Item 0250-101-0932 be increased by \$30.9 million to reflect additional General Fund resources available to the Trial Court Trust Fund to address the potential revenue loss, to be allocated by the Department of Finance on an as-needed basis (see Attachment 1).

**Rent Increase**—It is requested that Item 0250-001-0001 be increased by \$2,088,000 and Item 0250-001-3037 be increased by \$152,000 to reflect increased rent costs for the Supreme Court, Courts of Appeal, and the Administrative Office of the Courts.

**Technical Adjustment to Reduce Excess Expenditure Authority**—It is requested that Item 0250-001-0890 be decreased by \$280,000, reimbursements be decreased by \$1.7 million, and Item 0250-001-0001 be amended to eliminate excess expenditure authority within Program 30-Judicial Council.

"0855-111-0367—For transfer by the Controller, upon order of the Director of Finance, from the Indian Gaming Special Distribution Fund, to the Indian Gaming Revenue Sharing Trust Fund.....(25,000,000)

Provisions:

1. The amount of any transfer ordered by the Director of Finance pursuant to this item shall be the minimum amount necessary to allow the Indian Gaming Revenue Sharing Trust Fund to distribute the quarterly payments described in Section 12012.90 of the Government Code and meet its other expenditure requirements. Any remaining portion of the amount authorized to be transferred pursuant to this item shall remain in the Indian Gaming Special Distribution Fund.
2. ~~The Legislature finds and declares Notwithstanding Government Code Section 12012.85 and 12012.90, if the California Gambling Control Commission, acting for this purpose as the state gaming agency under various tribal state compacts, determines~~ that the amount authorized in this item is expected to be ~~sufficient~~ insufficient to allow the Indian Gaming Revenue Sharing Trust Fund to distribute the quarterly payments described in Section 12012.90 of the Government Code during the 2014–15 fiscal year. ~~Accordingly, the California Gambling Control The Commission, acting for this purpose as the state gaming agency under various tribal state compacts, shall not direct any funds to the Indian Gaming Revenue Sharing Trust Fund pursuant to Section 4.3.1(l) of the amended tribal-state compacts with the Morongo Band of Mission Indians, the Pechanga Band of Luiseño Indians, and the San Manuel Band of Mission Indians, and similar sections of any compacts or amended compacts ratified by the Legislature. to increase the revenue contribution to the Indian Gaming Revenue Sharing Trust Fund in Section 4.3.2.2 in an amount sufficient to provide each eligible recipient Indian tribe quarterly payments pursuant to Government Code Section 12012.90.~~
3. The Chairperson of the California Gambling Control Commission shall immediately submit a report to the Director of Finance, the Chairperson of the Joint Legislative Budget Committee, and the Legislative Analyst if he or she determines that the Indian Gaming Revenue Sharing Trust Fund will not have sufficient funds to distribute the quarterly payments described in Section 12012.90 of the Government Code during the 2014–15 fiscal year after consideration of the funds authorized for transfer by this item. No earlier than 15 days after submission of that report, the California Gambling Control Commission may direct funds to the Indian Gaming Revenue Sharing Trust Fund, ~~notwithstanding the requirements of Provision 2.~~

**Amendment to Government Code, State Treasurer's Office**

**Trailer Bill Language to Address the Payment of Banking Fees (Issue 001)**—It is requested that Government Code section 16502 be amended to provide the Treasurer with continuous appropriation authority from the General Fund to pay banking fees associated with the State of California's eight depository banks, if necessary (see Attachment A). The appropriation is capped at \$10 million per fiscal year. Due to historically low interest rates and recent changes to banking regulations, the State Treasurer's Office's use of compensating balances no longer provides the return necessary for its depository banks to recover the cost of providing the state's banking services.

## GOVERNMENT CODE SECTION 16502

16502. All other money in the State Treasury or under the control of the Treasurer belonging to or in the custody of the State, shall, so far as possible, be deposited by the Treasurer to the credit of the State in eligible banks. Any sum in the State Treasury so deposited is deemed to be in the State Treasury. Any other amount so deposited is deemed to be held in trust by the Treasurer. Notwithstanding Section 13340, and to the extent it is necessary, there is hereby continuously appropriated without regard to fiscal years, from the General Fund in the State Treasury an amount equal to the sum necessary to pay for fees associated with the provision of banking services provided to the State by eligible banks as determined by the Treasurer. The amount of the appropriation shall not exceed \$10 million in any fiscal year.
