BILL SUMMARY: Anti-Reproductive-Rights Crime

This bill would: 1) extend the repeal date of the Reproductive Rights Law Enforcement Act (Act) from January 1, 2009 to January 1, 2014, 2) require the Commission on Peace Officer Standards and Training (POST) to prepare guidelines establishing standard procedures law enforcement agencies should follow when investigating and reporting anti-reproductive-rights crimes and to transmit training bulletins via the internet to those law enforcement agencies.

FISCAL SUMMARY

The Commission on POST and the Commission on the Status of Women both indicate this bill would result in minor, absorbable costs.

This bill would not create a state reimbursable mandate as the bill's language is permissive.

COMMENTS

This bill would:

- Extend the repeal date of the Act from January 1, 2009 to January 1, 2014.
- Require the Commission on POST to prepare guidelines establishing standard procedures law enforcement agencies should follow when investigating and reporting anti-reproductive-rights crimes and to transmit training bulletins via the internet to those law enforcement agencies.
- Require the advisory committee convened by the Commission on the Status of Women to submit an additional report to the Legislature and other specified entities by December 31, 2011, as specified.
