BILL SUMMARY: Adjutant General: support programs.

This Administration sponsored bill would authorize the Adjutant General to establish support programs for the benefit of all Military Department service members and their families and establish, construct, or acquire facilities or equipment for these programs.

FISCAL SUMMARY

This bill would create the California Military Department Support Fund for the establishment of these programs. All funds received and expended would be private donations to the newly created special fund. The Military Department is unable to estimate the amount of donations it will receive as a result of this bill.

COMMENTS

The Department of Finance supports this Administration sponsored bill as it would allow the Military Department to establish support programs including morale, welfare, recreational, training, and educational programs for the benefit of all Military Department service members.

Existing law authorizes the Adjutant General to establish rules and regulations for the provision of morale, welfare, and recreational activities for members of the National Guard. This bill would extend the authority to establish support programs for the benefit of all Military Department service members including the California State Military Reserve, California Military Department Youth Program cadets, and their families. This bill would also allow the Adjutant General to establish, construct, or acquire facilities or equipment for these programs.

This bill would also authorize the Adjutant General and the Military Department to solicit and accept funds or other donations which would be deposited in the California Military Department Support Fund. The money in this special fund would be available, upon appropriation by the Legislature, solely for the purposes of establishing support programs. This bill would require the Adjutant General to conduct an internal audit of the fund and to report the findings of the audit to the Department of Finance on or before March 31, 2014, and on or before March 31 each year thereafter.
